- Broken down cars in neighborhood. Tarped car hasn't moved in 4 years. Tom to call Sheriff, get cars tagged. Advises homeowner to do the same.

- Question regarding fence staining. Homeowner borders the fence to be stained, and will email Tom for stain on her part of the fence.

Old Business:

- Mailbox Replacement 3 have been done in the last 2 months.
- Fence staining Puget Park Drive would like to do this all at once. Tom to investigate power washing. Tentative start date of July.
- Puget Park Drive blackberry bush removal blackberry bush containment will be added to the landscape contract at a cost of \$100 per month. Containment will be done 7 months of the year. Board approves 3/0.

- Hazard Tree work Our Arborist, Dan Douglas, attended the board meeting to discuss hazard tree work. When he identifies trees that need removal, it is important to obtain like bids for the work. Mike met with Dan to go over several trees that are leaning.
 There are 7 trees that need to be taken out, Port Gardner to get revised bid to include these.
- Misc: Mike will get the garage sale signs from Sherry and put them out on Tuesday before the garage sale this month. Nothing lined up yet for a work party, wood chips need to be dumped at trailheads based on newsletter map. A homeowner reported a small park that is never used and needs a lot of fixing. Board decided to have it dismantled rather than spend funds to improve an unused park. Port Gardner to order 4 No Trespassing signs. Board representatives to review the shed that may have been built over and above specifications and possibly over the property line.
